AFFIDAVIT FOR CHANGE OF NAME/CORRECTION ON DATE OF BIRTH



1. That I am the Deponent and conversant with facts deposed to herein.
2. That on my Primary School Leaving Certificate (PSLC) with Registration No: **07-052-08-1003** and Certificate No: **ODS08/127588** issued to me by Ondo State Ministry of Education having completed my Primary School Education at Baptist Primary School Ajapa-Ese-Odo; my name appears as **ABOYEWA EBIMIYENWEI** but was meant to be **ABOYEWA TAYE EBIMIYENWEI**.

That on my West African Examination Council (WAEC) June 2014 Certificate with Candidate No: **4290704010** and Certificate No: **NGWASSCS 20513984** Examination which was written at Okhuba-Ama High School Ajapa; my name and date of birth appear correctly as **ABOYEWA TAYE EBIMIYENWEI** and **10TH DAY OF APRIL, 1995** respectively.
4. That on my National Identity Card issued to me by the National Identity Management Commission (NIMC) my name appears as **JESSE EBIMIYENWEI TAYE** but was meant to be **ABOYEWA TAYE EBIMIYENWEI** and date of birth appears as **10TH DAY OF APRIL, 1997** instead of **10TH DAY OF APRIL, 1995**.

That at United Bank for Africa Plc (UBA) where I enrolled for my Bank Verification Number (BVN) and in my Account in the same Bank my name appears as **JESSE SAMUEL EBIMIYENWEI** but was meant to be **ABOYEWA TAYE EBIMIYENWEI** and date of birth appears **10TH DAY OF APRIL, 1997** instead of **10TH DAY OF APRIL, 1995**.
6. That all documents bearing any of the names are mine and remains valid but prefer now to be addressed as **ABOYEWA TAYE EBIMIYENWEI** and my correct date of birth should be **10TH DAY APRIL, 1995**.
7. That all Relevant Government Institutions, Ondo State Ministry of Education, National Identity Management Commission (NIMC), United Bank for Africa Plc (UBA), the General Public and Whom It May Concern to please take note of the above declarations, rely on the facts deposed to herein and assist in your capacity to do the needful.
8. That this affidavit is needed for record and official purposes.
9. That I depose to this affidavit in good faith, believing the contents to be true and correct to the best of my knowledge in accordance with Oath Act of Nigeria, 2004.
